# Learner Support Policy

Safeguard Training & Services 's management and staff are committed to providing enrolling and enrolled students with Language Literacy and Numeracy (LL&N) Needs and/or learning differences, with advice and support intervention options to assist with a student's ongoing learning and progress through the Safeguard Training & Services courseware.

## **Learner Support Procedures**

#### At enrolment

- Students identifying Learner Support needs during the enrolment process will be advised by Safeguard Training & Services staff of the support measures available at Safeguard Training & Services and through referral to support agencies. (Please refer to the following support agencies list)
- Safeguard Training & Services 's enrolment staff may request that a student with learner support needs undertake an LL&N test. Results from the test will be assessed and the course being enrolled in reviewed for appropriateness.
- Safeguard Training & Services 's management must be advised of all LL&N test results that identify significant Learner Support needs of enrolling students.
- Students identified as having significant Learner Support needs will be referred to support agencies and may be enrolled at Safeguard Training & Services with a reduced study load.

#### Post enrolment

- Following enrolment all the Safeguard Training & Services training staff will be available by appointment to provide Learner Support to enrolled students.
- Learner Support provided by the Safeguard Training & Services staff may include specific interventions identifying Australian Core Skills Framework (ACSF) training needs for learners at varying performance levels.

#### Pre assessment

- All Safeguard Training & Services training staff must review the specific support requirements of all students with learner support needs prior to each assessment event.
- Where reasonable adjustment is determined as necessary for a student with learner support needs advice must be provided to Safeguard Training & Services
- Training Coordinator detailing the reasonable adjustment being planned prior to the assessment event (email).

- Safeguard Training & Services 's Training Coordinator must approve each assessment that contains planning of reasonable adjustment.
- Reasonable adjustment applied to any assessment must be recorded and maintained on a student's enrolment records.
